REAR END CAR WRECK LEADS TO A \$50,000 JUDGEMENT FOR A MOTHER AND HER YOUNG SON.

On September 25, 2017, my clients, a mother, and her young son were driving south on Beltline Boulevard in Columbia, South Carolina. They would eventually come to a complete stop at a red light. However, the at-fault driver behind them was driving while distracted and rear-ended their vehicle causing both property damage and physical injuries.

After the wreck, my clients received medical treatment at the emergency room and follow up care with their physicians. The mother would miss multiple days of work and eventually lose her job as a result of missing numerous days of work due to attending doctor's appointments for her injuries. Her young son would suffer from anxiety every time he rode in the car with his mother as he was traumatized as a result of the wreck.

When I informed the insurance company of my clients' pain, suffering, and complaints, they attempted to minimize their damages and did not believe they were legitimate. The insurance company offered my client a measly \$267.00 for her injuries and not much more for her son.

She and I both were insulted by the insurance company's offer given everything that she went through. On top of this, her son was still suffering from severe anxiety from the wreck. I recommended that my client reject the settlement offer and allow me to file a lawsuit on behalf of her and her young son. I told her that I believed that a judge and/or jury would offer her more than the insurance company if we took the case to trial. And that's just what happened when we received a judgment in court for \$50,000.00 for their damages.

Results like this are what motivate insurance companies to treat injured victims fairly. Many times, cases can be settled without the need of filing a lawsuit and going to trial. However, sometimes a trial is needed to see that people are treated fairly. Whether it's settling a car accident case, or taking a case to trial, I am always here to fight for my clients.

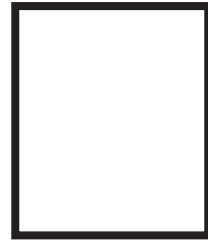
