Lisa Williams vs. Kenneth Williams: Docket No.: 2017-CP-40-03886

On March 18, 2017, Kenneth Williams was driving west on Broad River Road in Columbia, South Carolina. Ms. Williams, who is of no relation to Kenneth Williams, was in her vehicle stopped for traffic when Kenneth Williams struck the back of Ms. Williams' vehicle at a high rate of speed.

After the collision occurred, Kenneth Williams was observed by witnesses tossing a bottle of whiskey outside of his vehicle. Several witnesses to the wreck reported smelling alcohol coming from Kenneth Williams – including Ms. Williams and the investigating Trooper from the South Carolina Highway Patrol. When questioned about the whiskey bottle that was tossed out of his vehicle, and the alcohol that the witnesses could smell, Mr. Williams stated that he was not drinking while driving and denied that the bottle was his. He was ultimately charged with driving too fast for conditions and driving with an open container of alcohol.

Ms. Williams, along with myself, believed that Kenneth Williams was intoxicated by alcohol at the time of the wreck. Ms. Williams was injured in the wreck and went through months of medical treatment to recover from her injuries. Additionally, her vehicle was totaled. However, her major concern was that Kenneth Williams may engage in similar conduct and eventually hurt or kill another driver on the road in the future if he escaped being held responsible for his actions.

Initially, the insurance company only offered Ms. Williams a little over \$3,000.00 for her medical expenses, pain, suffering and the reckless conduct of Kenneth Williams for his actions that day. We both believed the settlement offer was insulting. However, after filing a lawsuit on behalf of Ms. Williams and exposing the reckless conduct that occurred, I was able to force this same insurance company to pay Ms. Williams a settlement that was over 10 times the amount of her medical bills.

Protecting our community by holding people responsible for their actions is a core principle of my law firm. Ms. Williams is now able to rest a little easier at night knowing that Kenneth Williams will-hopefully-think long and hard before putting our community in danger again.
